

## 2018 BUZZTIME® HISTORY TRIVIA SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT AFFECT YOUR CHANCES OF WINNING. THIS PROMOTION IS OPEN ONLY TO NATURAL PERSONS WHO ARE LEGAL RESIDENTS OF THE 50 UNITED STATES, WASHINGTON, D.C., AND WHO ARE AT LEAST EIGHTEEN (18) YEARS OF AGE AT THE TIME OF ENTRY. ENTRY IN THIS PROMOTION CONSTITUTES ACCEPTANCE OF THESE OFFICIAL RULES. VOID WHERE PROHIBITED BY LAW.

**1. ELIGIBILITY:** The 2018 Buzztime History Trivia Sweepstakes (the "Promotion") is open to legal residents (each a "Participant") in the 50 United States and the District of Columbia.

The **Promotion** is only open to Participants who:

- (a) are legal residents of one of the 50 United States, and Washington, D.C.; and
- (b) are at least 18 years old and of the age of majority or older in the state of their residence at the time of entry,

except for employees, officers, directors, agents and representatives of **NTN Buzztime, Inc.** ("Buzztime" or "Sponsor") and its affiliates (including without limitation its parent, sister and subsidiary companies, partnerships and other commercial entities), its advertising and promotion agencies and any other person directly connected with the production and distribution of or the supply of goods or services in connection with this Promotion, their respective owners, directors, officers, employees and agents (collectively, with Buzztime, hereinafter referred to as the "Released Parties") and their respective immediate families (mother, father, sister, brother, child, husband or wife, and their respective spouses, regardless of where they reside), and those living in the same household of any such individuals, whether or not legally related. Buzztime may change this schedule or terminate the Promotion at any time with or without notice.

- **3. HOW TO ENTER AND PLAY** Participants are eligible to participate and qualify for prizes listed below. **During the Promotion Period, Participant may enter the Promotion in the following ways:** 
  - Participant Entry via Gameplay: Participant must be a PlayersPlus® member to be eligible to win via gameplay during the Promotion Period. Participant can sign up for a PlayersPlus account via (i) participating locations, Buzztime entertainment devices at or (ii) online at http://www.buzztime.com/play. PlayersPlus registration is free. Participant must sign in using their PlayersPlus account and play at least one (1) scheduled Buzztime History Trivia game during the broadcast day and time at the dates listed above to be eligible for the Promotion. Participant will earn a maximum of one (1) entry for each set of Promotion Dates. Participant can earn a maximum of four (4) entries during the entire Promotion Period.

Free Mail in entries for Promotion Period 4 must be received by March 5, 2018

No purchase is necessary to sign up for PlayersPlus, play Buzztime trivia, or to enter the Promotion. No money or other thing of value may be collected, charged, contributed or exchanged as a condition of play or participation in the Promotion.

## 4. PRIZES:

 During the Promotion Period, a Participant entry will be drawn each week and awarded in denominations determined by Buzztime in the total amount of five hundred (\$500.00 USD) dollars in the form of an American Express\* gift card. The Approximate Retail Value ("ARV") of each weekly prize is five hundred (\$500.00) dollars. There will be a total of four (4) winners, subject to these Rules.

Total ARV of all prizes = \$2,000.00 total (USD). ARV of prizes are just that, approximations and are not guarantees of price or value.

Prizes are not exchangeable, transferable, or redeemable for cash. Winners must agree to abide by any restrictions in connection with the prizes, including the terms and conditions of the prize providers. Lost or stolen prizes will not be replaced. The winner(s) will be solely responsible for all applicable state, federal, and local taxes associated with the acceptance and use of any awarded prize. On or about two days after the deadline to receive free mail-in entries for each Promotion Date, Buzztime or its representative will conduct one random drawing for each Promotion Date (the "Drawing") from all eligible entries to determine potential winner. Potential winner(s) will be notified via the email address registered with PlayersPlus account or provided for in the free mail-in entry. Potential winners will have seven (7) days from time of email notification to accept the prize pursuant to Section 6 below. Entries are subject to verification by Buzztime and the potential winner is not declared final and shall not receive a prize until verified by Buzztime. Buzztime's decisions are final and binding on all matters relating to this Promotion. Any attempts to exceed the limit of number of entries into the Promotion by any method, including but not limited to, using multiple email addresses or accounts or robotic entries, are prohibited and Buzztime reserves the right to disqualify all suspect entries. An individual may not enter on behalf of another individual or transfer his/her entry to another person. - (c) bugs, viruses, worms, unauthorized human intervention in any part of the entry process or this Promotion or any other causes which impair the fairness, integrity or administration of the Promotion (in such event, Buzztime reserves the right, at its sole option, to modify, terminate or suspend this Promotion);

In the event that the operation of the Promotion is compromised due to virus, bugs, non-authorized human intervention or any other causes beyond the control of Buzztime which corrupts, or impairs administration, security, fairness or proper conduct of the Promotion, Buzztime reserves the right, in its sole discretion, to suspend, modify or terminate the Promotion in its entirety and to disqualify any individual who tampers with the entry process.
- 10. ARBITRATION/CLASS ACTION WAIVER/CHOICE OF LAW: Except where prohibited by law, each Participant agrees that (1) any and all claims, disputes and causes of action relating directly or indirectly, to the Promotion, and use of the Buzztime equipment and programming shall be resolved individually, without resort to any sort of class action and exclusively by arbitration or alternative dispute resolution as selected by Buzztime to take place in the county of San Diego, California, (2) any and all claims, judgments and awards shall be limited to actual out of pocket costs incurred, but in no event attorney's fees; and (3) in no event will a Participant be entitled to obtain additional awards beyond out of pocket costs and participants hereby waive all rights to claim punitive, incidental and consequential damages, other than for actual out of pocket costs and hereby waives any and all rights to have damages or awards multiplied or otherwise increased. Except where prohibited by law, all issues and questions regarding the Promotion and interpretation and validity of these "Official Rues" and the decisions of Buzztime and its agents in connection with the Promotion shall be governed by the laws of the State of California without regard for conflict of laws doctrine. Should any term of this rule or any other rule, term or condition of these Official Rules and any addendum or published notice referenced in these Official Rules be determined to be void, unenforceable or contrary to applicable law, such terms or conditions shall, but only to the extent necessary to bring the rule within the requirements of the law, be deemed to be severed from the other terms and conditions hereof and the remainder of the Official Rules shall remain in full force and effect. Buzztime reserves the right to amend these rules at any time with or without prior notice. Entry into the Promotion constitutes acceptance of these terms. Winners and Participants agree than any legal action arising in connection with the Promotion, whether in tort, contract or otherwise shall be heard exclusively in the courts of San Diego County, California.
