

2018 BUZZTIME® OUTTA THE PARK SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT AFFECT YOUR CHANCES OF WINNING. THIS PROMOTION IS OPEN ONLY TO NATURAL PERSONS WHO ARE LEGAL RESIDENTS OF THE 50 UNITED STATES, WASHINGTON, D.C., AND WHO ARE AT LEAST EIGHTEEN (18) YEARS OF AGE AT THE TIME OF ENTRY. 1. ELIGIBILITY: The 2018 Buzztime Outta the Park Sweepstakes (the "Promotion") is open to legal residents (each a "Participant") in the 50 United States and the District of Columbia.

The **Promotion** is only open to Participants who:

- (a) are legal residents of one of the 50 United States, and Washington, D.C.; and
- (b) are at least 18 years old and of the age of majority or older in the state of their residence at the time of entry,

Entries are subject to verification by Buzztime and the potential winner is not declared final and shall not receive a prize until verified by Buzztime. Buzztime's decisions are final and binding on all matters relating to this Promotion. Except where prohibited by law, all issues and questions regarding the Promotion and interpretation and validity of these "Official Rues" and the decisions of Buzztime and its agents in connection with the Promotion shall be governed by the laws of the State of California without regard for conflict of laws doctrine.
