



**2018 BUZZTIME® OUTTA THE PARK SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT AFFECT YOUR CHANCES OF WINNING. THIS PROMOTION IS OPEN ONLY TO NATURAL PERSONS WHO ARE LEGAL RESIDENTS OF THE 50 UNITED STATES, WASHINGTON, D.C., AND WHO ARE AT LEAST EIGHTEEN (18) YEARS OF AGE AT THE TIME OF ENTRY. ENTRY IN THIS PROMOTION CONSTITUTES ACCEPTANCE OF THESE OFFICIAL RULES. VOID WHERE PROHIBITED BY LAW.

1. ELIGIBILITY: The 2018 Buzztime Outta the Park Sweepstakes (the "Promotion") is open to legal residents (each a "Participant") in the 50 United States and the District of Columbia.

The **Promotion** is only open to Participants who:

- (a) are legal residents of one of the 50 United States, and Washington, D.C.; and
- (b) are at least 18 years old and of the age of majority or older in the state of their residence at the time of entry,

3. HOW TO ENTER AND PLAY Participants are eligible to participate and qualify for prizes listed below. **During the Promotion Period, Participant may enter the Promotion in the following ways:**

- **Participant Entry via Gameplay:** Participant must be a PlayersPlus® member to be eligible to win via gameplay during the Promotion Period. PlayersPlus registration is free. Participant must sign in using their PlayersPlus account and play at least one (1) scheduled Buzztime Baseball Trivia game during the broadcast day and time at the dates listed above to be eligible for the Promotion. Potential winners will have seven (7) days from time of email notification to accept the prize pursuant to Section 6 below. Entries are subject to verification by Buzztime and the potential winner is not declared final and shall not receive a prize until verified by Buzztime. Buzztime's decisions are final and binding on all matters relating to this Promotion. shall be limited to actual out of pocket costs incurred, but in no event attorney's fees; and (3) in no event will a Participant be entitled to obtain additional awards beyond out of pocket costs and participants hereby waive all rights to claim punitive, incidental and consequential damages, other than for actual out of pocket costs and hereby waives any and all rights to have damages or awards multiplied or otherwise increased. Except where prohibited by law, all issues and questions regarding the Promotion and interpretation and validity of these "Official Rules" and the decisions of Buzztime and its agents in connection with the Promotion shall be governed by the laws of the State of California without regard for conflict of laws doctrine. Should any term of this rule or any other rule, term or condition of these Official Rules and any addendum or published notice referenced in these Official Rules be determined to be void, unenforceable or contrary to applicable law, such terms or conditions shall, but only to the extent necessary to bring the rule within the requirements of the law, be deemed to be severed from the other terms and conditions hereof and the remainder of the Official Rules shall remain in full force and effect.
