



**2018 BUZZTIME® PLAY ALL DAY SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT AFFECT YOUR CHANCES OF WINNING. THIS PROMOTION IS OPEN ONLY TO NATURAL PERSONS WHO ARE LEGAL RESIDENTS OF THE 50 UNITED STATES, WASHINGTON, D.C., AND WHO ARE AT LEAST EIGHTEEN (18) YEARS OF AGE AT THE TIME OF ENTRY. ENTRY IN THIS PROMOTION CONSTITUTES ACCEPTANCE OF THESE OFFICIAL RULES. VOID WHERE PROHIBITED BY LAW.

1. ELIGIBILITY: The 2018 Buzztime Play All Day Sweepstakes (the "Promotion") is open to legal residents (each a "Participant") in the 50 United States and the District of Columbia.

The **Promotion** is only open to Participants who:

- (a) are legal residents of one of the 50 United States, and Washington, D.C.; and
- (b) are at least 18 years old and of the age of majority or older in the state of their residence at the time of entry,

except for employees, officers, directors, agents and representatives of **NTN Buzztime, Inc.** ("Buzztime" or "Sponsor") and its affiliates (including without limitation its parent, sister and subsidiary companies, partnerships and other commercial entities), its advertising and promotion agencies and any other person directly connected with the production and distribution of or the supply of goods or services in connection with this Promotion, their respective owners, directors, officers, employees and agents (collectively, with Buzztime, hereinafter referred to as the "Released Parties") and their respective immediate families (mother, father, sister, brother, child, husband or wife, and their respective spouses, regardless of where they reside), and those living in the same household of any such individuals, whether or not legally related. Buzztime may change this schedule or terminate the Promotion at any time with or without notice.

3. HOW TO ENTER AND PLAY Participants are eligible to participate and qualify for prize listed below. **During the Promotion Period, Participant may enter the Promotion in the following ways:**

- **Participant Entry via Gameplay:** Participant must be a PlayersPlus® member to be eligible to win via gameplay during the Promotion Period. Participant can sign up for a PlayersPlus account via (i) Buzztime entertainment devices at participating locations, or (ii) online at <http://www.buzztime.com/play>. PlayersPlus registration is free. Participant must sign in using their PlayersPlus account and play at least one (1) scheduled Buzztime Lunchtime Trivia, Countdown, or The Late Shift game during the broadcast day and time at the dates listed above to be eligible for the Promotion. The potential winner will have seven (7) days from time of email notification to accept the prize pursuant to Section 6 below. Entries are subject to verification by Buzztime and the potential winner is not declared final and shall not receive a prize until verified by Buzztime. Buzztime's decisions are final and binding on all matters relating to this Promotion. Except where prohibited by law, all issues and questions regarding the Promotion and interpretation and validity of these "Official Rules" and the decisions of Buzztime and its agents in connection with the Promotion shall be governed by the laws of the State of California without regard for conflict of laws doctrine.
