HOW TO ENTER THE CONTEST:

Entry Instructions for Eligible Participants: During each Contest Date, Contestant must sign in using his/her PlayersPlus account and play one (1) Movie Night Trivia Game **AND** one (1) Pop Culture Trivia Game at an Eligible Location. For clarity, Contestant must be a Buzztime PlayersPlus member for his/her score to qualify. Promotion not available outside Eligible Locations. Please email Sponsor at email@buzztime.com for questions related to Promotion availability/broadcast times.

Participant(s) can sign up for a PlayersPlus account through (i) Buzztime entertainment devices at Eligible Locations, (ii) online at www.buzztime.com/play, or (iii) by installing the Buzztime Entertainment App.¹ **PlayersPlus registration is free. No money or other thing of value may be collected, charged, contributed or exchanged as a condition of play or participation in the Promotion.**

Registration requires Contestant to provide his/her complete first and last name, valid e-mail address, and date of birth. As part of your registration, you may choose to agree to receive marketing e-mails and other communications from Sponsor. Contestant may unsubscribe or opt-out of the receipt of marketing e-mails or other communications from Sponsor at any time without impacting eligibility. The information associated with the Contestant's PlayersPlus account must (i) be true and accurate, and (ii) identify the actual Contestant in the Contest.

By registering as a PlayersPlus member, Contestant agrees that any information provided by Contestant or collected by Sponsor in connection with the Contest may be used by Sponsor in accordance with Sponsor's Privacy Policy located at www.buzztime.com/business/privacy-policy/ and Terms of Service located at www.buzztime.com/business/terms-of-service/.

Each Contestant may only establish, maintain, use and control only one PlayersPlus account. Sponsor reserves the right to verify a Contestant's eligibility before, during, or after the Promotion. For avoidance of doubt, Contestants may not "co-own" accounts. In the event Sponsor determines that Contestant opened, maintained, used or controlled more than one account, in addition to any other rights that Sponsor may have, Sponsor reserves the right to suspend or terminate any or all of your accounts and terminate, withhold or revoke the awarding of any prize.

Contestants may, in certain circumstances, communicate with, work with, or otherwise benefit from others with whom they have a preexisting relationship while participating in the Promotion. Entries generated by script, macro or other automated means are void.

For Eligible Participants using the Buzztime Entertainment App, his/her smartphone must have a touchscreen interface, internet access, an operating system capable of running downloaded applications that can connect to the internet to participate in this Promotion. Eligible Participant must allow his/her smartphone browser to enable cookies so he/she can participate in the Promotion, and enable location services (e.g., GPS). **Message and data rates may apply to which Eligible Participant is solely responsible.** Eligible Participants should consult their wireless service provider regarding its pricing plans. Eligible Participants should review their mobile device's capabilities for specific app instructions. In addition, the Contest interface may vary based on the type of device used at time of entry (e.g., Eligible Participant will need access to view TV(s) broadcasting the Promotion at Eligible Locations in order to use the Buzztime Entertainment App).

HOW TO WIN: The Contest consists of ten (10) separate Contest Dates (i.e., One (1) Contest Instance per Contest Date).

Eligible Participants: All Eligible Participants will compete against one another for a chance to win one (1) of three (3) prizes for each separate Contest Instance as further described below. The Eligible Participant with the highest cumulative points at the end of each Contest Instance from across all Eligible Locations wins the applicable prize for that Contest Instance. In the case of a tie for places one (1) thru three (3) at the conclusion of a Contest Instance, such players will split the applicable prize evenly as further described below.

CONTEST RULES: Each Contest Instance consists of two games: one (1) Movie Night Trivia Game **AND** one (1) Pop Culture Trivia Game. Contestant must log-in to his/her account prior to start of the Contest Instance for his/her score to qualify.

Game Instructions:

- Each Contest Instance consists of two (2) games: one (1) Movie Night Trivia Game and one (1) Pop Culture Trivia Game.
- Each game consists of 7 questions, each question worth a maximum of 1,000 points (i.e., total of 14 questions per Contest Instance). Contestant will have 20 seconds to answer each question.
- Once the question is proposed, Contestant will be given 5 possible answers to choose from. Depending on the device a Contestant uses, the questions and possible answers may be displayed on the Contestant's device. The Contestant may need to refer to the TVs displaying the information at the Buzztime locations. Once the question and possible answers are displayed, the question will go away and be replaced with clues.
- Three clues, one after the other, will be displayed on TV and Buzztime entertainment devices (i.e., not on Mobile Playmaker) to help Contestant identify the correct answer.
- The timer, represented by the points system, will start to decrease, starting at 1000 until the timer reaches 0.

- In summary, Contestant will only receive the amount of points that they earned per question (locked into) in the speed that they answer the question in – the faster the correct answer, the more points Contestant receives.
- The Contestant can change his/her answer at any time before the timer hits 0, but the points earned get lower each time. Points are only awarded for correct answers, once the counter has expired.
- There is no penalty for getting the answer wrong or failing to answer. Contestant will receive no points for incorrect answers.
- The Contestant with the highest cumulative points after 14 questions from across all Eligible Locations wins the prize for that Contest Instance. In the case of multiple winners at the conclusion of a Contest Instance, such players will split the prize evenly.

If at any time, for any reason whatsoever, the Contestant leaves the Contest, or for any reason loses contact with the Contest (e.g., game device loses battery, there is a loss of internet connection for any reason), they can attempt to log back into the current Contest Instance. Sponsor shall not be liable for: (1) any electronic miscommunications or failures, technical hardware or software failures of any kind, lost or unavailable network connections, or failed incomplete, garbled or delayed computer transmissions which may limit a Contestant's ability to participate in the Promotion; or (2) any technical malfunctions of the telephone network, computer on-line system, computer equipment, software, program malfunctions or other failures, delayed computer transactions or network connections that are human, mechanical or technical in nature, or any combination thereof, including any injury or damage to Contestant's or any other person's computer or mobile device related to or resulting from downloading the App or otherwise in connection with this Promotion.

The Sponsor's decisions will be final and binding on all parties. PRIZE:

Prizes: Subject to confirmation of the winner's eligibility to receive a prize consistent with Sponsor's Official Rules, the prizes per Contest Instance are as follows:

1st Place: \$400.00

2nd Place: \$60.00

3rd Place: \$40.00

All prizes will be in the form of a check.

Ties: IN THE CASE OF A TIE FOR FIRST (1ST) THROUGH THIRD (3RD) PLACE, SUCH PLAYERS WILL SPLIT THE CASH PRIZE EVENLY AND WILL RECEIVE THE CASH PAYOUT IN THE FORM OF A CHECK (E.G., TWO PLAYERS TIE FOR 1ST PLACE, EACH PLAYER WILL RECEIVE A CHECK IN THE AMOUNT OF \$200.00).

Total Approximate Retail Value ("ARV") of all prizes during the entire Promotion Period = \$5,000.00 total (USD).

HOW TO CLAIM PRIZE, AFFIDAVIT, AND RELEASE: The potential winners are subject to verification of eligibility and compliance with these Official Rules. **After the conclusion of the Promotion Period (i.e., October 31, 2019)**, the potential winner(s) will be notified by Administrator as soon as practicable via e-mail at the respective e-mail address registered with his/her PlayersPlus account (the “**Notification**”). The notification email will come from buzztime@email.buzztime.com. For avoidance of doubt, Sponsor will only issue a prize and any accompanying tax forms to the individual person identified in the PlayersPlus account for the winning account. Sponsor will use the PlayersPlus account information to contact and verify potential winners. Out of date or incorrect account information at the time you enter the Promotion may disqualify Contestant from receiving a prize. Failure to provide valid, working contact information in connection with your account may result in termination of that PlayersPlus account and forfeiture of any prize awarded.
