# LEXITOPIA TRIVIA, IMMORTAL WORDS TRIVIA, HISTORY TRIVIA, AND TUNED IN TRIVIA GAME RULES:

- Each 15-minute game consists of 10 questions, each question worth a maximum of 1,000 points.
- Contestant will have 15 seconds to answer each question.
- Once the question is proposed, Contestant will be given 4 possible answers to choose from.
  Depending upon the device a Contestant uses, the questions and possible answers may be
  displayed on the Contestant's device. The Contestant may need to refer to the TVs displaying the
  information at the Buzztime locations. Once the question and possible answers are displayed, the
  question will go away and be replaced with clues.
- Two of the incorrect answers will disappear at allotted times.
- The timer, represented by the points system, will start to decrease, starting at 1000 until the timer reaches 0.
- In summary, Contestant will only receive the amount of points that they earned per question (locked into) in the speed that they answer the question in – the faster the correct answer, the more points Contestant receives.
- The Contestant can change his/her answer at any time before the timer hits 0, but the points earned get lower each time. Points are only awarded for correct answers, once the counter has expired.
- There is no penalty for getting the answer wrong or failing to answer. Contestant will receive no points for incorrect answers.

# **MOVIE NIGHT AND POP CULTURE TRIVIA GAME RULES:**

- Each 15-minute game consists of 7 questions, each question worth a maximum of 1,000 points.

  on the Contestant's device. The Contestant may need to refer to the TVs displaying the information
  at the Buzztime locations. Once the question and possible answers are displayed, the question will
  go away and be replaced with clues.
- Three clues, one after the other, will be displayed on TV and Buzztime entertainment devices (i.e., not on Mobile Playmaker) to help Contestant identify the correct answer.
- The timer, represented by the points system, will start to decrease, starting at 1000 until the timer reaches 0.

#### 4. PRIZE:
