**Entry Instructions for Eligible Participants:** During each Entry Period, Eligible Participants must sign in using his/her PlayersPlus account to play Buzztime SIX® Trivia Game (the "**Game**") at an Eligible Location. For clarity, Participant must be a Buzztime PlayersPlus member for his/her score to qualify. Promotion not available outside Eligible Locations. Participant(s) can sign up for a PlayersPlus account through (i) Buzztime entertainment devices at Eligible Locations, (ii) online at <u>https://www.buzztime.com/play</u>, or (iii) by installing the Buzztime Entertainment App.<sup>1</sup> **PlayersPlus registration is free.** Eligible Participant must sign in using his/her PlayersPlus account and play the Game on Buzztime authorized devices at Eligible Locations for his/her score to qualify. **No money or other thing of value may be collected, charged, contributed or exchanged as a condition of play or participation in the Promotion.** 

For Eligible Participants using the Buzztime Entertainment App, his/her smartphone must have a touchscreen interface, internet access, an operating system capable of running downloaded applications that can connect to the internet to participate in this

Promotion. Eligible Participant must allow his/her smartphone browser to enable cookies so he/she can participate in the Promotion, and enable location services (e.g., GPS). **Message and data rates may apply to which Eligible Participant is solely responsible.** Eligible Participants should consult their wireless service provider regarding its pricing plans. Eligible Participants should review their mobile device's capabilities for specific app instructions. In addition, the Promotion user interface may vary based on the type of device used at time of entry (e.g., Eligible Participant will need access to view TV(s) broadcasting the Promotion at Eligible Locations in order to use the Buzztime Entertainment App). The use of GPS spoofing or any other technology that misrepresents GPS locations and being located at an Eligible Location is strictly prohibited and will disqualify any player from eligibility.

HOW TO WIN: The Promotion Period consists of six (6) separate Entry Periods.

**Eligible Participants:** All Eligible Participants will compete against one another for a chance to win one (1) of six (6) prizes for each separate Entry Period as further described below. The Eligible Participant with the highest cumulative points at the end of each Entry Period from across all Eligible Locations wins the applicable prize for that Entry Period. In the case of a tie for place one (1) at the conclusion of an Entry Period, such players will split the applicable prize evenly as further described below.

**<u>GAME RULES</u>**: The Game is based on SIX® Trivia. Each Game is sixty (60) minutes and consists of four (4) rounds featuring questions from six (6) different categories.

**Round 1 (Easy SIX):** Consists of 6 multiple-choice questions - 1 question for each of the 6 categories. Each question is worth a maximum of 250 points. A perfect score (i.e., 1,500 points) in Round 1 gets an additional 500 points (i.e., 2000 total points). Each question has 4 possible answers. The timer, represented by the points system, will start to decrease, starting at 250 until the timer reaches 0. In summary, Contestant will only receive the amount of points that they earned per question (locked into) in the speed that they answer the question in – the faster the correct answer, the more points Contestant receives. Contestant can change his/her answer at any time before the timer hits 0, but the points earned get lower each time. Points are only awarded for correct answers, once the counter has expired. There is no penalty for getting the answer wrong or failing to answer. Contestant will receive no points for incorrect answers.

**Round 2 (Match SIX):** Consists of 12 matching based questions (4 matching pairs per question), 2 questions per category. Contestant must match the highlighted words, numbers, names, titles or phrases in the left column to their match in the right column before time runs out. The maximum points per question is 1000 points. If Contestant scores 1000 points on any question, he/she will receive an additional 500 points (i.e., up to 1500 points per question). A perfect score in Round 2 gets Contestant an additional 1,000 points. There is no penalty for getting the answer wrong or failing to answer. Contestant will receive no points for incorrect answers.

**Round 3 (Marathon SIX):** Consists of 18 multiple-choice questions, 3 per category. Each question has 3 possible answers. Points awarded for correct answers increase per question (e.g., Question 1 - 500 points, Question 3 - 560 points, etc.). As points increase per question, the allowed time to answer decreases. As in Round 1, the longer Contestant takes to answer, the lower the points he/she may receive. A perfect score in Round 3 gets an additional 2000 points. There is no penalty for getting the answer wrong or failing to answer. Contestant will receive no points for incorrect answers.

**Round 4 (Final SIX):** Consists of 6 multiple-choice questions, 1 per category. Each question has 4 possible answers. Each question has a starting maximum value of 1,000 points. As in Round 1, the timer, represented by the points system, will start to decrease, until it reaches 0. The difference in Round 4 is that Contestant must select a multiplier (up to 6X) prior to the question appearing. Contestant will be presented with the question category concurrently at the time of selecting the multiplier. Each multiplier can only be used once. There is no penalty for getting the answer wrong or failing to answer. Contestant will receive no points for incorrect answers.

If at any time, for any reason whatsoever, the Contestant leaves the Promotion, or for any reason loses contact with the Promotion (e.g., game device loses battery, there is a loss of internet connection for any reason), they can attempt to log back into the current Entry Period. #### PRIZE:

#### **Eligible Participant Prizes:**

Subject to confirmation of the winner's eligibility to receive a prize consistent with Sponsor's Official Rules, the prizes are as follows:

The Eligible Participant with the highest cumulative points at the end of each Entry Period from across all Eligible Locations wins the \$250.00 USD cash prize for that Entry Period.
