DIVISIONAL ROUNDS (ENTRY PERIODS 3-6): Divisional round will consist of four (4) Divisions (Blue, Red, Green and Purple). Each Division will have fifty (50) Locations. The average of the top five (5) highest individual scores at the Location during each respective Period will be added together to determine each Division winner. The best three (3) out of four (4) Weekly Location Scores are added together to determine Location's ranking among all eligible Locations in respective Division. In the event of a tie, the tie breaker will be the Location's individual's highest score
